DURATION AND TERMINATION

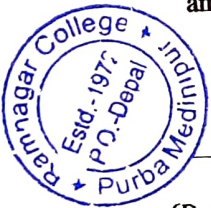
- 1) This MOU shall enter into force on the date of signing.
