- Any other common issues relating to our aims and objectives.

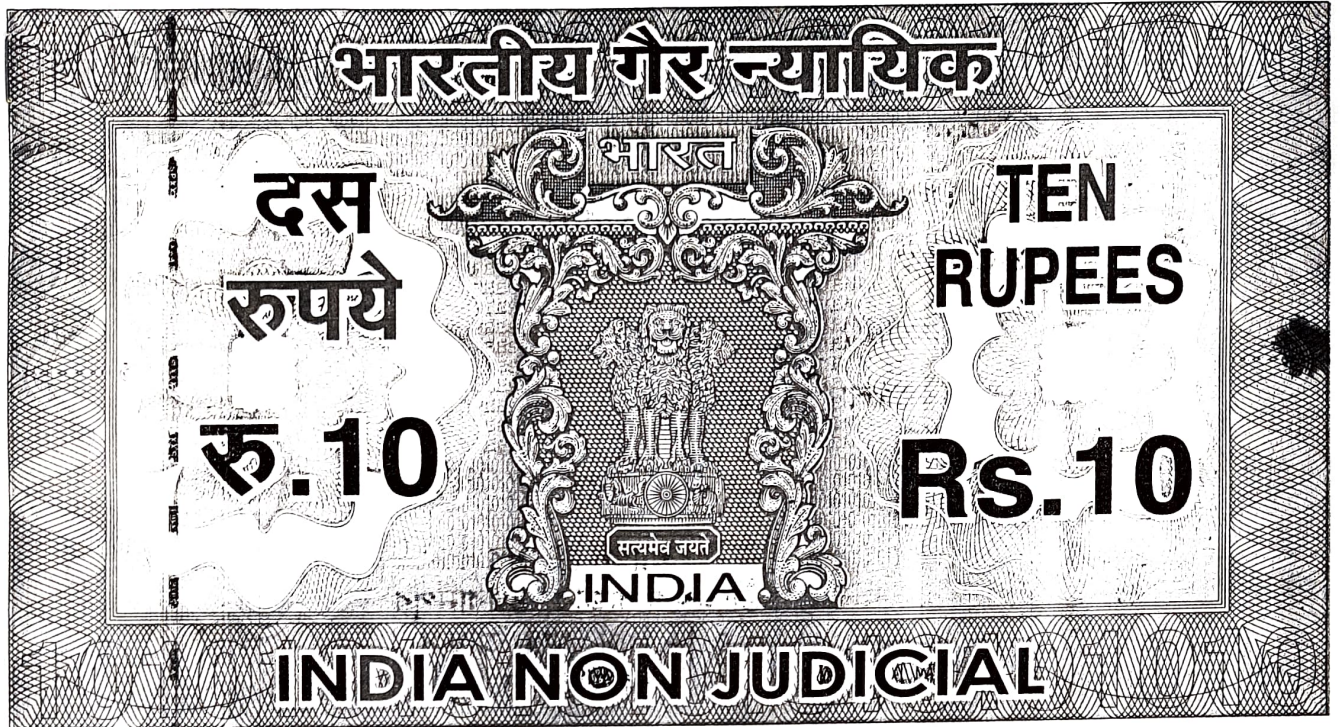


